What did Presque Isle Audubon accomplish in 2023? I'm noticing this time of year is when many organizations notify their supporters about the projects they completed the previous year. Sounds like a good idea for us as well! Here's a wrap-up of PIA's efforts for 2023:

Provided 21 birding backpacks (each with 2 pairs of binoculars and 2 bird ID guides) to all public libraries in Erie and Crawford Counties.

Sent 2 local educators to National Audubon's Hog Island camp for Educator's Week.

Hosted The Great Backyard Bird Count at TREC.

Participated in Discover Presque Isle with a pavilion full of activities for youngsters.

Organized and conducted the three-day Festival of the Birds for 150+ guests.

Provided funding for bird-window collision prevention at TREC.

Provided bird seed for the feeders at the Public Safety Building on Presque Isle.

Presented 7 monthly programs, online and in person, centered on birds and birding.

Updated our Strategic Plan for 2024-26.

Redoing the Strategic Plan took over a year and was time well-spent. The Board now has clear and attainable standards to guide their work for the next three years.

CHRISTMAS BIRD COUNT - 2023

Well, another successful and fun Christmas Bird Count is in the books! Presque Isle Audubon held its local Christmas Bird Count on December 16, 2023. We had nearly 30 adventurous participants (whom we thank whole-heartedly!!) spread out across the Erie County count circle, which includes Presque Isle SP. Our efforts yielded 85 different species, which is above the average of 76 for counts held over the past 10 years. The only higher species count in the past decade was 87 in 2014.

The weather was unusually balmy with highs in the 50s this year. This may account for the nice number of bird species encountered. Not surprisingly, the Ring-billed gull captured the prize for most individuals counted of a single species at 6,172. Thank you, again, to all of our participants & hope to see you all next year!



WINTER RAPTOR SURVEY

If you want to add a new birding venture to your winter schedule, you should consider joining the PAWRS project - the Pennsylvania Winter Raptor Survey. (This project happens to be affiliated with HMANA - Hawk Migration Association of North America). Each year Greg Grove, editor of Pa Birds and eBird reviewer, coordinates and initiates this survey (which ran this year from January 13 to February 10). Volunteers establish a route on country roads in Erie County, in this case, and travel by car from mid-morning to mid-afternoon to record the number of designated raptors spotted traveling somewhere between while minimum of 10 to 20 miles and a maximum of 100 miles. A condition to be observed while doing the count is that there is good weather no fog, no high wind and only moderately heavy rain and snow. Miles traveled should be recorded with no overlaps. It is important that you report them accurately.

There are presently three established routes in Erie County. Erie Southwest by Scott Stoleson, Lake Erie Shore by Mary Birdsong and Erie West by Janet Price. This year, on January 22, Janet, Pat Howell and Issy Lawrie traveled 76 miles over the Erie West Route for a period of 4 hours and 55 minutes. They recorded 11 Red Tails, 1 Kestrel, 4 Red Shoulders, 3 Bald Eagles and 1 Sharp Shinned. Working together to gather information for avian research is rewarding in more ways than one! If you'd like to add a positive experience to your life and contribute to this effort, there are still routes open in Erie County and elsewhere. Contact Greg Grove at gwg@psu.edu.
